IN 2021, WE PLACED EIGHT ADULT GUIDE DOGS AND PROVIDED REVIEW TRAINING TO 47 TEAMS THAT RECEIVED DOGS IN PREVIOUS YEARS. DUE TO COVID, WE DID LITTLE PUBLIC SPEAKING IN 2021. WE HAVE AN ONGOING PROGRAM AT THE NEW LISBON STATE CORRECTIONAL INSTITUTION (A MEDIUM SECURITY MEN'S PRISON) WHERE WE HAVE INMATES RAISE AND TRAIN PUPPIES, MUCH LIKE REGULAR PUPPY RAISERS. WE CONDUCT WEEKLY CLASSES FOR THE 20 INMATES CURRENTLY RAISING PUPPIES FOR US. WE DISCONTINUED THE PROGRAM IN OXFORD DUE TO COVID RESTRICTIONS. THE PROGRAM IS CALLED "PAWSFORWARD."
