OCCUPAWS ALSO EDUCATES OTHER ORGANIZATIONS AND THE PUBLIC ABOUT VISUAL IMPAIRMENTS AND GUIDE DOGS. IN 2024, WE PLACED EIGHT GUIDE DOGS AND PROVIDED REVIEW TRAINING TO 55 TEAMS THAT RECEIVED DOGS IN PREVIOUS YEARS. WE HAVE AN ONGOING PROGRAM AT NEW LISBON CORRECTIONAL FACILITY (MEDIUM SECURITY MENS PRISON) WHERE INMATES RAISE AND TRAIN THE DOGS; THE PROGRAM IS CALLED PAWSFORWARD.
